

## How should I file a complaint?

The following is key information when filing a complaint with FDACS:

1. Name of complainant/victim
2. Nature of Incident
3. Pesticide(s) involved
4. Date and timer of incident
5. Name and address of physician
6. Address of the farm or company

Indicate wheter you wish to remain anonymous. If you think pesticides may have been used incorrectly and you would like an inspection conducetd at the place where you work, you should call or write:

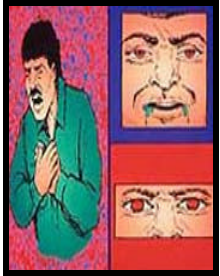

## What are the signs and symptoms related to pesticide poisoning?



**P**esticides are chemicals which, if not used properly, may be harmful to human health. One or more of the following symptoms may mean that a person has been

exposed to pesticides:

*Protect yourself, it's your health!*

- ◆ Burning eyes, nose or skin
- ◆ Itching skin rash or blisters
- ◆ Headache
- ◆ Dizziness
- ◆ Weakness
- ◆ Excessive sweating
- ◆ Stomach ache or cramps
- ◆ Chest pain

Employers must give the attending doctor the name, EPA Registration Number, and active ingredient of the pesticides that might have made a worker or handler sick. Also, upon request, employers are required to provide to the employee or to the doctor medical information from the product labeling such as antidote and first aid as well as the application method and how exposure occurred.

## HOW TO PREVENT PESTICIDE POISONING?

- ☒ **The label is the Law!** Read and follow the label directions before use.
- ☒ Wear the personal protective equipment that is required on the label.
- ☒ Pesticides may get on your clothes at work. Wear clean clothes each day that cover your skin.
- ☒ Wash work clothes separately from other clothes in hot water and detergent..
- ☒ Wear long pants, long-sleeved shirts, socks and shoes or boots.
- ☒ After work each day, wash your whole body, including your hair, with plenty of water and soap.
- ☒ Wash your hands after work and before you eat, drink, smoke, chew gum or tobacco, or go to the bathroom.
- ☒ Stay out of areas where pesticides are being applied or where they are drifting.
- ☒ Never take pesticide or pesticide containers home from work.
- ☒ Never place pesticides in beverages containers or other vessel than the properly labeled container.
- ☒ Keep children away from areas where pesticides might be present.
- ☒ Keep pesticides in a locked cabinet, away from children.

## Workers Protection Standard

### Your employer must:

1. Give you basic information about pesticides before you work in or near treated areas
2. Be sure that you are trained in pesticide safety **BEFORE** you handle any pesticides.
3. Assure that workers are trained **before** they have more than 5 separate days of entry into areas treated with pesticides within the last 30 days, or a re-entry interval has been in effect.
4. Make sure that you get medical help if you become ill from pesticides while working.
5. Provide workers and handlers with decontamination supplies such as water, soap and disposable towels, and a clean change of clothes for handlers at the work site.
6. Display information about pesticides applied in or near areas where you work at the central location.

*Remember that:*

- Employers cannot ask you to work in areas where pesticides are being applied
- Employers cannot fire you for asking for information about Worker Protection Standard (WPS) or for filing a complaint related to WPS.

*It's the Law!*
